AAUW POLICY FOCUS FOR 2012-2013

AAUW is committed to promoting women's issues through its public policy program. "The public policy program underscores AAUW's mission of advancing equity for women and girls through advocacy, education, philanthropy, and research" (AAUW, 2011). The organization informs its members of important policy issues so that they are able to support these issues on the local, state, and national levels. "Issue advocacy isn't just about AAUW lending its name to an issue, or speaking on Capitol Hill. Issue advocacy is about AAUW members and all citizens concerned with equity being knowledgeable and aware of the current status of important issues" (AAUW's FEDERAL POLICY AGENDA, 2011).

During 2012-13, the public policy principles for action will cover several important areas. These areas are: 1) the belief that quality education is the foundation of our society; 2) the belief that all individuals need to have affordable housing, health care, and a clean environment; 3) the belief the all individuals have a right to privacy, freedom from violence, and reproductive rights; 4) the belief that affirmative action is essential to the well-being of people throughout the world; 5) the belief that we need international policies to promote human rights, and justice.

The biennial action priorities will include the support of a strong public school system, the economic selfsufficiency of all women, and the guarantee of equality, individual rights, and social justice for a diverse society.

Social security, Medicare, and Medicaid will need our support over the next two years. These entitlement programs are essential for a large segment of our population. AAUW will be a major player in supporting these important programs since it advocates for economic self-sufficiency of women.

THE LEGAL ADVOCACY FUND

AAUW Legal Advocacy Fund (LAF) support has been instrumental in the success of many gender discrimination cases during its almost 30-year history. Other LAF initiatives include community and campus outreach programs, an online resource library with downloadable advocacy tools, a Legal Referral Network, and various related research reports.

AAUW's strategic case support program provides financial and organizational backing for a select number of cases that have the potential to provide significant protection for all women. The funds come directly from the generous contributions of AAUW members who support the Legal Advocacy Fund.

As always, personal donations to LAF are greatly appreciated. Your check should be made out to **AAUW Funds** and on the memo line you must indicate LAF. National has given this fund a number designation that I must indicate on the form accompanying the donation. If there is no specific designation from you, all money goes into the general operation expenses of the national office. It is also important that all personal donations from you must come to me first so that our Schenectady Branch gets the appropriate credit for the donation.

You may have heard about the disappointing Supreme Court ruling in the *Wal-Mart v. Dukes* class action sex-discrimination case. This narrow, 5-4 decision makes it harder for women and other workers to systemically challenge unequal treatment in the workplace. AAUW will continue to be on the cutting edge of future legislation or efforts to remedy the new, problematic standards created by the Supreme Court.

What can you do to prevent this sort of sex discrimination in the first place? You can work to strengthen our nation's fair pay law **by donating to AAUW's Legal Advocacy Fund (LAF)**! LAF helped support the women of Wal-Mart in this important case and seeks out and supports other sex discrimination cases which have the potential to make a difference for all women.

I look forward to receiving your donations to LAF. In order to insure that our branch is recognized for contributions, all AAUW contributions, including LAF and EOF, should be made through our Schenectady Branch.
